



LIABILITY WAIVER AND HOLD HARMLESS AGREEMENT

THERE ARE INHERENT RISKS IN PARTICIPATION IN RECREATIONAL AVIATION ACTIVITIES AND FLIGHT TRAINING. OPERATORS AND PASSENGERS OF RECREATIONAL AIRCRAFT, BY PARTICIPATION, ACCEPT THE RISK INHERENT IN SUCH PARTICIPATION OF WHICH THE ORDINARY OR PRUDENT PERSON IS OR SHOULD BE AWARE. PILOTS AND PASSENGERS HAVE A DUTY TO EXERCISE GOOD JUDGEMENT AND ACT IN A RESPONSIBLE MANNER WHILE USING THE AIRCRAFT, AND TO OBEY ALL ORAL AND WRITTEN WARNINGS, BOTH PRIOR TO AND DURING THE USE OF THE AIRCRAFT.

To the best of my knowledge, I am in good physical condition and believe myself fully medically able to participate in flight training activities. I hold a valid driver's license issued by a US state, and have not been refused an FAA medical certificate, or had one revoked. I am fully aware of the risks and hazards connected with the participation in general aviation activities, including physical injury or even death, and hereby elect to voluntarily participate in said training, knowing that the associated physical activity may be hazardous to me and my property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OR LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or loss or damage to property owned by me, as a result of participation in these activities.

I understand that the aircraft operated by AvSport of Lock Haven were manufactured in accordance with Light Sport Aircraft airworthiness standards, and do not conform to standard category airworthiness requirements.

I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE, AvSport of Lock Haven, its parent company Microcomm Consulting, the City of Lock Haven, Piper Memorial Airport, Sentimental Journey to Cub Haven, and their officers, servants, agents, contractors, and employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while participating in flight training and aviation activities, or while on or upon the premises where such activities are being conducted.

It is my expressed intent that this release and hold harmless agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVE, DISCHARGE, and CONVENTION TO SUE the above named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be constructed in accordance with the laws of the Commonwealth of Pennsylvania.

In signing this release, I acknowledge and represent that I HAVE READ THE FORGOING Waiver of Liability and Hold Harmless Agreement, UNDERSTAND IT AND SIGN IT VOLUNTARILY as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreements have been made; and I EXECUTE THIS RELEASE FOR FULL, ADEQUATE AND COMPLETE CONSIDERATION FULLY INTENDING TO BE BOUND BY SAME.
